WHEREAS,

Since 2013-14, Asian Educational Institute (AEI) have gained a strong foothold in the best agencies, organizations in the field of academia. Honourable Chaiman, Mr. Tarsem Saini, is an icon in Indian industry and his Management team, has always been striving hard to promote education for the community, especially in the remote rural areas as well as urban areas. Feeling the necessity of a competent and quality teacher, it was decided to establish a teacher education college in 2013-14 under the name and style of, "Asian College of Education" at Sirhind Road, Patiala. Our premier institution provides an excellent curricular as well as curricular environment for optimum and holistic development with special emphasis on moral development, social service and community linkage. Under the support of the Management and vision of the Director/Principal, Dr. Sanjeev Kumar Modi, the spectrum of the college activities has enhanced to a remarkable extent.

WHEREAS,

DEESHAA- An Education & Awareness Society, are a Non-Governmental Organization registered by the Government of Haryana, based in Pinjore, District Panchkula. We are determined to empower the deprived, both in rural and urban areas with education, without charging. We shall teach academics to children who do not have access to education so that they could compete with the rest of the students and make a living for themselves in future. We also intend to develop the technical and professional skills of adults who are unable to earn a livelihood. We shall have a special emphasis on women who are still dependent on others and especially able people who need support. Again without charging, we shall teach skills like mobile phone repair, computer-based skills, stitching, sewing, spoken English etc, so that the

deprived could earn livelihood. Further, we shall spread awareness regarding health care, prevention of various diseases, sanitation and cleanliness

NOW THEREFORE Asian Educational Institute and DEESHAA an NGO Agree as Follows:

I. OBJECTIVE OF THIS MEMORANDUM OF UNDERSTANDING

1.1. The aim of this Memorandum of Understanding (MOU) is to establish a framework for strengthening operational partnership between Asian Educational Institute (AEI), and DEESHA. Under the auspices of this framework, the Parties shall develop specific activities, projects or programmes to be implemented in a spirit of co-operation and common commitment to further the protection and assistance of EWS category students and other persons of concern to purely relating to the education and innovation and to seek solutions for their problems. Respecting the separate mandates and activities of each organization, the MOU accordingly outlines areas for collaboration.

1.2 The activities to be carried out in furtherance of this MOU shall be focused mainly on the educational requirements and any training as may be prescribed by both Parties to the agreement. Such activities and areas of cooperation shall include but are not limited to conducting resettlement interviews and preparing Resettlement Registration Forms, legal assistance, medical services, psycho-social counselling, best interest determinations, profiling and health focused projects and any other areas of cooperation as may be mutually agreed upon by both Parties. Recognizing the human and other resource implications of the objectives of this MOU, due diligence shall be made to efforts to support each other in these respects to the extent feasible and in the appropriate manner.

Statement of Purpose

A. Asian Educational Institute's (AEI) mission and values strongly endorse partnerships with the community that advances the quality of life and the educational, intellectual, artistic, civic, cultural and economic aspirations for all those living or working in our neighboring communities. The AEI promotes student placements in applied settings as a valued part of a student's education process.

B. The Institution's mission is stated in its bylaws and articles of incorporation.

C. The AEI and the DEESHAA recognize the opportunity for positive learning experiences and mutual benefit for each, and for enrolled students. The Institution supports the goals and objectives of the DEESHAA Society

Priorities

A. Program Activities.

Activities will be accomplished in accordance with the applicable Student Agreement (e.g.,

Internship, Service Learning), reviewed and agreed upon by the STUDENT, Institution, and the NGO prior to the start of the experience.

1. The STUDENT(S) will:

a. Participate in all relevant grooming and training required by the NGO (DEESHAA), (Training and Orientation) of this document.

b. Model appropriate, professional behavior when working with clients and when on the NGO's educational and Social activities.

c. Support NGO's events that are part of the student learning experience as required by faculty member.

d. Meet the goals of the NGO's program and the academic course in which the STUDENT is enrolled.

B. Safe and Productive Environment.

The NGO (DEESHAA) will:

a. Give STUDENT(S) a complete social and educational assistance, and ensure that STUDENT(S) are aware of all emergency procedures and is able to act responsibly in the event of an emergency.

b. Ensure that STUDENT(S) are aware of the unique nature of the population and/or clients of the NGO and has received an orientation and any additional training the NGO deems necessary to work with this population.

C. The Asian Educational Institute (AEI) will ensure that STUDENT(S) agree(s) to the following:

1. Abide by the NIIT AGENCY's rules and regulations while on site and when working with NGOs future associations.

2. Ensure that their interactions with students are safe, positive and productive.

3. Support the DEESHAA's program and its objectives by performing the student's grooming activities stated in the Program Activities section of this document.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called as the 'MOU') is entered into on

this the 16th of March 2022, for organizing the entrepreneurship development and Skill Development activities by and between Asian Educational Institute, Patiala and DEESHAA- an Education & Awareness Society

Asian Educational Institute, Opp. Tricone City, 10th Milestone, Sirhind Road, Patiala (hereinafter referred as 'AEI', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

And

DEESHAA (here in after referred to as “Second Party”, organization which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

- A) First Party is an educational institute imparting education at undergraduate and postgraduate levels.
- B) AEI & DEESHAA believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Education and providing learning and skill development opportunities.

Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and

advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

- 1.1 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing entrepreneurial mindset which help student to decide certain amount of learning sessions as a career building measures keeping in mind the needs of the educational institute, the Second Party.
- 1.2 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, learning experience into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2 SCOPE OF THE MOU

- 2.1 The budding graduates from the institutions could play a key role in economic development of the country through establishing enterprises. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 The budding graduates from the institutions could play a key role in economic development of the country through establishing enterprises. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.3 **Curriculum Design:** First Party will give valuable inputs to the Second Party in designing teaching / training methodology and suitably customize the curriculum so that the students fit into the current scenario especially those belong to the EWS

categories and the NGO may play a key role in future to assist such students

- 2.4 **Training & Visits:** Training followed by job exposure visits will give an insight in to the latest developments / requirements of even startups / enterprise setup. The training and exposure provided to students through this association will build confidence and prepare the students to have a smooth transition from academic to professional career. The First Party will provide its professional resources & training expertise for the hands-on training of the learners enrolled with the Second Party.
- 2.5 **Intellectual Support and Social Skills:** Both parties to extend the necessary support to conduct professional and Social Skills and awareness programs to the students.
- 2.6 Both Parties to obtain all internal approvals, consents and permissions of whatsoever nature required for offering the future course of associations on the terms specified herein
- 2.7 There is no financial commitment on the part of the **both the parties**, If there is any financial consideration, it will be dealt separately.

CLAUSE 3 INTELLECTUAL PROPERTY

Nothing contained in this MOU shall, by express grant, implication, Estoppels or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4 VALIDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms. during which period **AEI**, the First Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **DEESHAA**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In

the event of Termination, both parties have to discharge their obligations.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that AEI and DEEKSHAA are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
