Instructions for paper-setter - The question paper will consist of three sections i.e., Section A. B, and C. Section A and B will have four questions each from the respective sections of the syllabus out of which the candidate will be required to attempt two questions each. Each question will carry 12 marks. Section C will be compulsory with 11 short answer type questions of 2 marks each, which will cover the entire syllabus. Question paper should be set strictly according to the syllabus and well distributed from all over the syllabus. In case there are parts in a question, separate marks for each part should be indicated in the question paper.

Instructions for the candidates - Candidates are required to attempt at least two questions from the section A and B of the question paper and the entire section C.

Course Objective - The course helps to understand various terminologies, concepts of strategies including the term war, strategy, grand strategy, tactics etc. besides differentiating/modern warfare from earlier types also identifying the definitions and principles of war.
