

ARTICLES OF ASSOCIATION, RULES, REGULATIONS
AND CONSTITUTION OF ASIAN SOCIETY FOR EDUCATION VILLAGE
BARAN.TEHSIL AND DISTT. PATIALA

Article-1.Membership

All the persons living in Patiala District can become the ordinary member of this Society by paying a membership fees of Rs.200/- or an associate member by paying a membership fee of Rs. 100/- for one year only along with the application for membership with the Secretary of the Society. The Secretary of the Society shall produce such application before the president of the Society for acceptance. The General Body of the Society shall be constituted by the ordinary members only.

Article -2. Composition of the Governing Body.

There shall be a Governing body (also called the Executive) consisting of not less than 7 members and not more than 21 members (including office bearers and executive members) in which the management of the Society is entrusted as stated in the Memorandum of Association of the Society. The following are entrusted the management of the Society for three years.

Article:-3 Cessation of member ship.


A member shall cease to be a member of the Society by voluntarily submitting his/her resignation in writing to the President.

A member shall cease to be a member on his/her death.

A member shall cease to be a member if his/her membership having been cancelled by a resolution passed by the Governing body for this purpose.

A member shall forfeit his/her membership by continuously becoming a defaulter of monthly contribution for more than 3 months at a time.

Article:-4 Re-Admission

A member who resigned or was removed from the membership of the Society may seek re-admission, by giving his/her name again to the Gen. Secy. of the Society. The Governing body shall have the discretion to admit or reject his/her application by observing all formalities in the admittance of a member.

Article:-5 Election.

The members of the Governing body shall be elected by majority of ordinary members from amongst themselves after every three years at the annual general meeting of the Society to be held in the month of April or as early as possible thereafter. The office bearers shall be elected by the members of the Governing body of the Society from time to time.

Article:- Management

The Governing body shall carry on the business or affairs of the Society in accordance with its objects and may from time to time alter the rules/byelaws for the management of the Society.

Article:-7.Powers & Duties of Governing Body.

PRESIDENT

The President of the Society shall preside over all the meetings of the Society and shall advise the Secretary on various agendas produced by the Secretary in the meeting of the Secretary.

VICE PRESIDENT

The Vice President of the Society will perform all the necessary duties as delegated to him by the president and shall preside over the meetings in the absence of the President.

GENERAL SECRETARY

The Gen. Secretary shall convene all meetings of the Society. Issue General Circulars and notices and maintain the minute's books of the meetings. The Secretary will sign on behalf of the Society all receipts for all the sums of monies, properties received as subscription contributions, gifts and donations etc. and may also assign or delegate his powers of authority to any office bearer of office to sign such receipts on behalf of the Society.

PRESS SECERTARY

The Press Secretary shall give the news to the news papers and other media and collect other matter.

CASHIER

Article:-8 Amendment.

Amendments to the rules and regulations of the Society may be made by a Resolution to be a part at a general meeting of the General body of the Society specially convened for the purpose. 21 days-clear notice shall be given to all the ordinary members for the proposed amendment and such notice shall be given deemed as served when the notice is sent under postal certificate of posting.

Article:-9.Dissolution.

If the Society needs to be dissolved it shall be dissolved as per provisions laid down under section 13 and 14 of the societies Registration Act 1860. The Society may be dissolved by a resolution to the effect passed by $3/4^{\text{th}}$ of the total member of the Society and the funds and assets and other properties as left shall, be handed over to some other Society having the similar aims and objects. No portion or funds or properties shall be distributed between the members of this Society.
